

ATF is revoking 68 revenue rulings, revenue procedures, ATF rulings, and ATF procedures, issued between 1954 and 1986, which have been found to be obsolete.

ATF Ruling 87-1

After conducting a thorough review of all published rulings and procedures, ATF has found 68 rulings and procedures which are obsolete because of expiration or because of changes in laws or regulations. Revocation of most of these rulings and procedures is the last step in the implementation of the revised law or regulations which incorporated or revoked the substance of the applicable ruling or procedure. Others were temporary rules or transitional rules which have expired. Revoking these rulings and procedures does not re-

flect any change in the regulatory
policies of the Bureau.
